This Management's Discussion and Analysis ("MD&A") supplements, but does not form part of, the consolidated financial statements of the Invenio Resources Corporation ("Invenio" or the "Company") and the notes thereto for the year ended 31 July 2014. Consequently, the following discussion and analysis of the financial condition and results of operations for the Company should be read in conjunction with the consolidated financial statements for the year ended 31 July 2014, which have been prepared in accordance with International Financial Reporting Standards ("IFRS"), consistently applied.

General

The Company was incorporated in the Province of British Columbia on 20 December 1996. The Company's Registered and Records Office is at Suite 1010 – 789 West Pender Street, Vancouver, BC, Canada.

Highlights, significant events and transactions

On 14 January 2014, the Company closed a non-brokered private placement of senior unsecured debentures (the "Debentures") for gross proceeds of \$30,000. The debentures have a minimum face value of \$1,000, each bearing interest of 10% per annum over a two year term issued together with bonus warrants. The principal amount and all accrued and unpaid interest shall be due and payable in full on 14 January 2016 (the "Maturity Date"). The Debentures all rank pari passu in priority among each of them and the principal and accrued interest may be pre-paid after one year from the date of issuance, in whole or in part (pro-rata), provided that a pre-payment penalty must also be paid to the Debenture holders equal to 75% of the amount of interest that would accrue from the date of pre-payment on the Maturity Date.

On 8 July 2014, the Company announced the resignation of Ken Booth as CEO, President and Director of the Company effective immediately. The board thanked Mr. Booth for his dedicated work on behalf of the shareholders. Allan W. Williams, director, has been appointed as interim CEO and President and Ronnie D. Doman has been appointed as a director. Mr. Doman is a Chartered Accountant and previously served as the Company's CFO.

The reduced loss during the periods ended 31 July 2014 and 2013 is the result of a reduction in exploration and evaluation activity during the period, as well as an ongoing focus on cost control.

The loss during the period ended 31 July 2011 results from the Company ramping up its exploration activity and increased operational processes.

The loss during the period ended 31 July 2012 resulted from the Company writing-off significant exploration properties.

Results of operations

The comprehensive loss for the fiscal year ended 31 July 2014 was \$188,556 which compares to a comprehensive loss of \$326,731 during the same period in 2013. The main fluctuations in costs are as follows:

The Company decided not to proceed with the Ganes Creek and Candle Hill Gold properties, which has halted its exploration and evaluation expenditures during the current period. The decrease is consistent with management's expectations.

Liquidity and capital resources

The Company's working capital deficiency at 31 July 2014 was \$440,750, compared with \$304,824 at 31 July 2013.

Cash used in operating activities during the year ended 31 July 2014 totalled \$32,793 (Comparative Period - \$148,921).

Cash generated in financing activities during the year ended 31 July 2014 totalled \$30,000 (Comparative period - \$Nil).

Cash generated in investing activities during the year ended 31 July 2014 totalled \$Nil (Comparative period - \$50,000).

The Company has no recent history of profitable operations. Therefore, it is subject to many risks common to comparable companies, including under-capitalization, cash shortages and limitations with respect to personnel, financial and other resources as well as a lack of adequate revenues.

It will be necessary for the Company to arrange for additional financing to meet its ongoing requirements.

Management believes it will be able to raise equity capital as required in the long term, but recognizes the risks attached thereto. Although the Company has been successful in the past in obtaining financing, there can be no assurance that it will be able to obtain adequate financing in the future or that the terms of such financing may be favourable.

Capital management

The Company manages its capital structure and makes adjustments to it, based on the funds available to the Company, in order to support the acquisition and exploration of exploration and evaluation properties. The Board of Directors does not establish quantitative return on capital criteria for management, but rather relies on the expertise of the Company's management to sustain future development of the business. The Company defines capital that it manages as share capital.

Management reviews its capital management approach on an on-going basis and believes that this approach, given the relative size of the Company, is reasonable.

The Company is in the business of exploration and evaluation and has no source of operating revenue. Operations are financed through the issuance of capital stock. Capital raised is held in cash in an interest bearing bank account and in guaranteed investment certificates until such time as it is required to pay operating expenses or exploration and evaluation costs. The Company is not subject to any externally imposed capital restrictions. Its objectives in managing its capital are to safeguard its cash and its ability to continue as a going concern, and to utilize as much of its available capital as possible for exploration activities.

Risk factors

Companies face many and varied kinds of risks. While risk management cannot eliminate the impact of all potential risks, the Company strives to manage such risks to the extent possible and practical. Following is the risk factor most applicable to the Company.

Environmental

Exploration and development projects are subject to the environmental laws and regulations of the jurisdictions within which the Company is conducting its operations. As such laws are subject to change, the Company carefully monitors proposed and potential changes, and ensures that it is and will be in strict compliance.

Various non-governmental organizations dedicated to environmental protection monitors, amongst others, the mining industry. These organizations have in the past commenced actions with the regulatory agencies or the courts to prevent or delay resource extraction activities.

Key management personnel are persons responsible for planning, directing and controlling the activities of an entity, and include executive and non-executive directors. During the year ended 31 July 2014, aggregate remuneration of \$94,895 (2013 – \$195,697) was paid or accrued to key management personnel. Share-based payments of \$Nil (2013 – \$Nil) were granted to key management personnel. Included in prepaid amounts and other current assets is \$3,000 (2013 - \$3,000) paid to a related party for prepaid rent.

The above transactions are measured at their exchange amount, which is the amount of consideration established and agreed to by the related parties. Amounts due to related parties are unsecured, non-interest bearing and have no fixed term of repayment.

Off-balance sheet arrangements

The Company has no off-balance sheet arrangements.

Critical accounting judgements and key sources of estimation uncertainty

In the application of the Company's accounting policies, management is required to make judgments, estimates and assumptions about the carrying amount and classification of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revisions affect only that period, or in the period of the revision and future periods, if the revision affects both current and future periods.

The following are the critical judgments and areas involving estimates, that management have made in the process of applying the Company's accounting policies and that have the most significant effect on the amount recognized in the condensed interim consolidated financial statements.

a) Rehabilitation Provisions

Rehabilitation provisions have been assessed based on the Company's internal estimates. Assumptions, based on the current economic environment, have been made which management believes are a reasonable basis upon which to estimate the future liability. These estimates take into account any material changes to the assumptions that occur when reviewed regularly by management. Estimates are reviewed annually and are based on current regulatory requirements. Significant changes in estimates of contamination, restoration standards and techniques will result in changes to provisions from period to period.

Actual rehabilitation costs will ultimately depend on future market prices for the rehabilitation costs which will reflect the market conditions at the time the rehabilitation costs are actually incurred.

b) Exploration and Evaluation Expenditures

The application of the Company's accounting policy for exploration and evaluation expenditure requires judgment in determining whether it is likely that future economic benefits will flow to the Company, which may be based on assumptions about future events or circumstances. Estimates and assumptions made may change if new information becomes available. If, after expenditure is capitalized, information becomes available suggesting that the recovery of expenditure is unlikely, the amount capitalized is written off in the profit or loss in the period the new information becomes available.

Investor relations activities

With respect to public relations, the Company's policy is to provide information from its corporate offices to investors and brokers directly.
